2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a review of the patients with cirrhosis during the COVID-19 pandemic. The topic is within the scope of the WJG. (1) Classification: Grade B and Grade D; (2) Summary of the Peer-Review Report: The authors summarized the current epidemiology, pathophysiological basis of liver injury, clinical characteristics, outcomes, and management strategies in patients with cirrhosis and COVID-19. comprehensive. However, the language needs to be polished. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 1 figure. A total of 104 references are cited, including 95 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade C. A language editing certificate issued by SNAS was provided. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJG. 5 Issues raised: (1) The language classification is Grade C.
