It is a nice work and successful diagnosis. However, the surgical treatment should be written in detail and carefully. are 4 figures. A total of 10 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, and written informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 1 grant. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors' information should be put in the first page; (2) The "Author Contributions" section is missing. Please provide the author contributions; (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (5) The references' number cited in the text should be superscript; and (6) Authors should always cite references that are relevant to their study. Please check and remove any references that not relevant to this study. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
