Science Editor: 1 Scientific quality: The manuscript describes a case report of the spontaneous clearance of chronic hepatitis C virus post-liver transplant. The topic is within the scope of the WJH. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors reported three different cases on timeline with chronic hepatitis C related cirrhosis undertaken for liver transplant with spontaneous resolution of HCV infection over next few years. They are interesting to note for future reference and for better understanding the immune mechanisms of human body towards viral infections at different stages of disease; and (3) Format: There are 2 tables. A total of 27 references are cited, including no references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, and written informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJH. 5 Issues raised: (1) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (2) The references cited in the text should be superscript; and (3) The "Case Presentation" section was not written according to the Guidelines for Manuscript Preparation. Please
