The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The manuscript deals with an important topic to assess patient and procedural factors associated with lower sedation requirements for</p>	[ Y ]

endoscopy. This study had a large sample size and these findings suggest factors predictive of tolerance with lower sedation requirements for EGDs. However, the methodology and interpretation of results should address; and (3) Format: There are 2 tables and 3 figures. A total of 25 references are cited, including 5 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The Institutional Review Board Approval Form and written informed consent were waived. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; and (4) The references cited in the text should be put in the square bracket, then make them be superscript. 6 Re-Review: Required. 7
