The topic is within the scope of the WJCC. (1) Classification: Grade D and Grade C; (2) Summary of the Peer-Review Report: The study is well done, the material is large enough and the methods look reliable. However, the authors should briefly discuss the limitations of the</p>	[Y]

current testing strategy (PCR-based mutation detection methods with sequencing of the entire gene, and multiplex ligation - dependent probe amplification) to detect silent carriers of pathologic genetic disorders. The questions raised by the reviewer should be answered; and (3) Format: There are 3 figures. A total of 17 references are cited, including no references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade C and Grade B. A language editing certificate issued by JWEDIT was provided. 3 Academic norms and rules: The authors need to provide the CARE Checklist-2016 with page number, and written informed consent provided by the patient. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 1 grant. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The language classification is Grade C.
