outcomes of high-grade aneurysmal subarachnoid hemorrhage patients with coiling and ventricular intracranial pressure monitoring. Overall, this manuscript is very well written. The results are very interesting. The questions raised by the reviewers should be answered; (3) Format: There are 4 tables; (4) References: A total of 26 references are cited, including 1 reference published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
