2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a retrospective study of the usefulness of computed tomography based three-dimensional reconstructions to assess the critical shoulder angle. The topic is within the scope of the WJO. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: This study compared assessment of the critical shoulder angle by CT-based reconstructions and conventional X-ray. Although the</p>	[Y]

value obtained from CT is about 2 degree less than that from X-ray, authors found the results of these two measures were strongly correlated and would be affected by the observer's experience. This experience may less affect the CT result. The study is interesting. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 5 figures. A total of 15 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. The authors are native English speakers. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJO. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Recommendation: Conditional acceptance.
