The topic is within the scope of the WJCC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: This case report is written in a good assay and very interesting. However, there are some points need to be improved. The authors should add this information in the Introduction and indicate the</p>	[Y]

norepinephrine type for this case (as the lab results) in the first paragraph of Discussion. Physical examination must add pulse rate, respiratory rate, and body temperature. Blood and/or urine sugar should be added in the laboratory examinations. The questions raised by the reviewers should be answered; and (3) Format: There are 4 figures. A total of 20 references are cited, including 10 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the CARE Checklist, and informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Natural Science Basic Research Program of Shaanxi Province; and Science and Technology Development Incubation Fund Project of Shaanxi Provincial People's Hospital. The topic has not previously been published in the WJCC. The corresponding author has published 3 articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); and (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
