The topic is within the scope of the WJCC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors analyze the dynamics of host immune responses to COVID-19, the role of effector mechanisms of the immune systems as a possible contributing factor to developing severe forms of COVID-19. A total of 70 references are cited, including 64 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations.
