(1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors have reviewed the recent progress in using tolerogenic dendritic cells as a therapeutic alternative in the treatment of type 1 diabetes. authors did very well on the literature review involving tolerogenic dendritic cells for treatment of autoimmune diabetes mellitus. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 2 figures. A total of 71 references are cited, including 21 references published in the last 3 years. There are 3 self-citations (Ref. 24, 41, 44). The topics of the self-citations are related to this study. 2 Language evaluation: Classification: Two Grades A. A language editing certificate issued by Filipodia was provided. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by CONACyT and by the Department of Clinical Immunology Research of the Biochemical Sciences Faculty. The topic has not previously been published in the WJD. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents.
