2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a review of the non-alcoholic fatty liver and kidney disease. The topic is within the scope of the WJG. (1) Classification: Grade C and Grade C; (2) Summary of the Peer-Review Report: The authors reviewed the epidemiology, risk factors, genetics, implications of gut dysbiosis, and specific pathogenic mechanisms linking</p>	[Y]

non-alcoholic fatty liver disease (NAFLD) to chronic kidney disease (CKD). They addressed the pathogenic mechanism such as ectopic lipid accumulation, cellular signaling abnormalities, insulin resistance. The manuscript should focus on the association of NAFLD with CKD and refine the uncorrelated contents. It is suggested to update references and provide current information such as liver-kidney axis. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 3 figures. A total of 153 references are cited, including 53 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search.

4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (3) the author should number the references in
