2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a minireview of the AI-assisted endoscopic detection of early EC. The topic is within the scope of the WJG. (1) Classification: Grade B and Grade A; (2) Summary of the Peer-Review Report: This manuscript reviews the studies of AI in the screening of esophageal neoplasia including squamous cell carcinoma and adenocarcinoma. This manuscript is written well, and we understand the present status of AI in the detection and diagnosis of early esophageal cancer.</p>	[Y]

However, there are several issues need to be addressed. Is there the study that showed AI's ability to measure the depth of esophageal adenocarcinoma? Authors should present these studies if there is it. How is the application status of AI in the detection and diagnosis of esophageal cancer in comparison with that of gastric cancer and colon cancer? The questions raised by the reviewers should be answered; and (3) Format: There are no tables or figures. The authors need to add some tables or figures. A total of 46 references are cited, including 26 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade A. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (2) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author's name, with no spaces; and (3) The authors need to add some tables or figures. 6 Re-Review: Required. 7
