(1) Classification: Grade C; (2) Summary of the Peer-Review Report: The manuscript reports a narrative review focuses on the latest available data on diagnosis, treatment and prevention of T2DM in youth and suggests potential areas for</p>	[Y]

future research. The manuscript is well written and easy to read. However, some questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 2 figures. A total of 139 references are cited, including 46 references published in the last 3 years. There are 3 self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Filipodia was provided. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJD. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) Please obtain permission for the use of picture(s). If an author of a submission is re-using a figure or figures published elsewhere, or that is copyrighted, the author must provide documentation that the previous publisher or copyright holder has given permission for the figure to be re-published; and correctly indicating the reference source and copyrights.
