inhibitors which are showing favourable risk/benefit ratio. It is interesting. However, the introduction on general DM complications and general risk factors should be reduced. The questions raised by the reviewer should be answered; and (3) Format: There is 1 table. (4) References: A total of 54 references are cited, including 20 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
