(1) Classification: Grade C; (2) Summary of the Peer-Review Report: This manuscript describes a single case of presumed carbon dioxide embolus associated with carbon dioxide insufflation during endoscopic thyroidectomy. has value in that it introduces a new clinical concept to anesthesiologists and surgeons who might be unaware of this possible condition. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 3 figures. A total of 28 references are cited, including 12 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by MedE was provided. 3 Academic norms and rules: The authors provided the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Health Bureau of Shapingba District, Chongqing, China. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (5) Authors should always cite references that are relevant to their
