The topic is within the scope of the WJCC. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: This is an interesting study about the roxadustat in the treatment of peritoneal</p>	[Y]

dialysis patients with renal anaemia. The results have some clinical significances, and well discussed. The questions raised by the reviewers should be answered; (3) Format: There is 1 table and 3 figures; (4) References: A total of 31 references are cited, including 13 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Two Grades B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Liaoning Province Key R&D Guidance Program, Liaoning Province Grassroots Health and Family Planning Appropriate Technology Promotion Project. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide the
