2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a retrospective cohort study of the diagnosis of anorectal tuberculosis by polymerase chain reaction, GeneXpert and histopathology anal fistula patients. The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: Early diagnosis and treatment for tuberculosis</p>	[Y]

infected anal fistula is import, and PCR is useful for diagnosis of TB in fistula-in-ano rather than Gene Xpert, histopathology. Especially, PCR for pus is most sensitive. Anal fistula of tuberculosis tends to be complex and non-healing fistula. This manuscript is very impressive. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 2 figures. A total of 26 references are cited, including 3 references published in the last 3 years. There are 4 self-citations (Ref. 5, 9, 12, 14). The topics of the self-citations are related to this study. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by a native English speaker was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. The written informed consent was not provided. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) The "Article Highlights" section is missing. Please add the "Article

	<p>Highlights” section at the end of the main text; (4) Authors should always cite references that are relevant to their study.
