The questions raised by the reviewers should be answered; and (3) Format: There are 4 figures. A total of 45 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B and Grade A. A language editing certificate issued by editage was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, and Written informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. 5 Issues raised: The authors did not provide original pictures. Please provide the original figure documents.
