2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a review of the outer retinal barrier's malfunction in the occurrence and progression of diabetic macular edema. The topic is within the scope of the WJD. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The paper does not focus just on the role of the outer retinal barrier in diabetic macular edema but rather on retinal and choroidal biomarkers in diabetic retinopathy. However, either the content or the title and purpose should be changed. The</p>	[Y]

questions raised by the reviewer should be answered; and (3) Format: There are 6 figures. A total of 97 references are cited, including 10 references published in the last 3 years. There are 3 self-citations, which are related to this review. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJD. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) Please obtain permission for the use of picture(s). If an author of a submission is re-using a figure or figures published elsewhere, or that is copyrighted, the author must provide documentation that the previous publisher or copyright holder has given permission for the figure to be re-published; and correctly indicating the reference source and copyrights.
