2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a case report of the asymptomatic traumatic rupture of an intracranial dermoid cyst. The topic is within the scope of the WJCC. (1) Classification: Grade B and two Grades C; (2) Summary of the Peer-Review Report: Previous studies reported that most of the intracranial dermoid cyst ruptures were spontaneous, and only a few were traumatic, with asymptomatic much rarer than the</p>	[Y]

symptomatic ruptures. Authors reported the rare case of asymptomatic traumatic rupture of an intracranial dermoid cyst. The text is relatively well-organized with logical formatting, and it is of appropriate length. The questions raised by the reviewers should be answered; and (3) Format: There are 2 figures. A total of 15 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Two Grades A and Grade B. A language editing certificate issued by MedSci was provided. 3 Academic norms and rules: The written informed consent of treatment is nor provided. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) Authors should always cite references that are relevant to their study. Please check and remove any references that not relevant to this study; and (3) Please provide the written informed consent of treatment of the patient. 6 Recommendation: Conditional acceptance.
