The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: This is an interesting study addressing the association of COVID -19 with liver injury. specialties. The questions raised by the reviewers should be answered; and (3) Format: There are no tables and figures. A total of 65 references are cited, including 59 references published in the last 3 years. There is 1 self-citation (Ref. 4). The topic of the self-citation is related to this study. 2 Language evaluation: Classification: Grade C. A language editing certificate issued by Xiaoxiang Borui Biotechnology was provided. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by Novel Coronavirus Pneumonia Emergency Project of University of South China, Technology Plan Project-Basic Research Project of Prevention and Treatment of the Novel Coronavirus Pneumonia, Key Research and Development Program of Hunan Province.
