The topic is within the scope of the WJGO. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The manuscript clarifies the current evidence for targeted therapies in GI cancer by evaluating the latest data regarding anti-EGFR, HER2, VEGF, PI3K/AKT, TGF-β, MET, WNT, PARP and immunotherapies. And Targeting these molecules</p>	[Y]

will improve the outcomes of patients with GI cancer. The review concept is clear. And the manuscript is well and concisely written. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 1 figure. A total of 96 references are cited, including 37 references published in the last 3 years. There is 1 self-citation (Ref. 52). The topic of the self-citation is related to this study. 2 Language evaluation: Classification: Two Grades B. A language editing certificate issued by KN International was provided. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by Grant-in-Aid for Scientific Research. The topic has not previously been published in the WJGO. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) If an author of a submission is re-using a figure or figures published elsewhere, or that is copyrighted, the author must provide documentation that the previous publisher or copyright holder has given permission for the figure to be re-published; and correctly indicating the reference source and copyrights.
