The topic is within the scope of the WJG. (1) Classification: Two Grades A and Grade B; (2) Summary of the Peer-Review Report: The manuscript uses the colonic transit test and rectal anal manometry to subtype constipation and detect corresponding indicators in patients with</p>	[Y]

Parkinson's disease with constipation and functional constipation, with the aim of clarifying the colonic and rectal motility characteristics of PDC and providing a basis for the treatment of PDC. This study is of value to guide the treatment of PDC. Very interesting study. And the manuscript is well written. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 1 figure. A total of 28 references are cited, including 3 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade A and two Grades B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) DOI numbers are missing in the reference list. Please provide the DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; and (4) Authors should always cite references
