(1) Classification: Two Grades B; (2) Summary of the Peer-Review Report: The authors concluded that AR is superior to NAR, which is in accordance with the results of other previous meta-analysis. and the results match the objectives of the study. Statistical analysis is solid and the weaknesses of the study are well described in the discussion part. The questions raised by the reviewers should be answered; (3) Format: There are 2 tables and 5 figures; (4) References: A total of 52 references are cited, including 15 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
