cited, including 12 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade C. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Open Projects of the Discipline of Nanjing University of Chinese Medicine supported by Academic Priority discipline of Jiangsu Higher Education Institutions. 333 Project of Jiangsu Province, China. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents.
