discussion; and (3) Format: There are 4 figures. A total of 18 references are cited, including no references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, and written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJGS. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) The "Case Presentation" section was not written according to the Guidelines for Manuscript Preparation. Please re-write the "Case Presentation" section, and add the "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND FOLLOW-UP" sections to the main text, according to the Guidelines and Requirements for Manuscript Revision; and (4) The same title of the figures should be combined, i.e., Figure 1...A: ; B: ;. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
