diagnosis, treatment, and prognosis. However, some references should be added in it; and (3) Format: There are 3 tables and 2 figures. A total of 149 references are cited, including 113 references published in the last 3 years. There are 3 self-citations, which are related to this review. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by 3 grants. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents.
