The questions raised by the reviewer should be answered; and (3) Format: There is 1 Figure. A total of 97 references are cited, including 21 references published in the last 3 years. There are 3 self-citations, which are related to this review. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by 1 grant. The topic has not previously been published in the WJSC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s).
