post-ERCP adverse events in cirrhotic vs non-cirrhotic patients. The manuscript is well-written, interesting and easy to read. The questions raised by the reviewers should be answered; and (3) Format: There are 14 tables and 1 figure. A total of 13 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. The authors are native English speakers. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJH. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; and (5) Authors should always cite references that are relevant to their study. Please check and remove any references that not relevant to
