The topic is within the scope of the WJG. (1) Classification: Two Grades B; (2) Summary of the Peer-Review Report: The paper reviewed is a thorough review of the immunological and rhematological manifestations of viral hepatitis. It is well-written and the authors present the information in an</p>	[Y]

orderly and concise fashion, and the figures and tables attached are appropriately illustrative of the paper content. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 1 figure. A total of 123 references are cited, including 36 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Two Grades B. A language editing certificate issued by Editage was provided.

3 Academic norms and rules: No academic misconduct was found in the Bing search.

4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJG.

5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) If an author of a submission is re-using a figure or figures published elsewhere, or that is copyrighted, the author must provide documentation that the previous publisher or copyright holder has given permission for the figure to be re-published; and correctly indicating the reference source and copyrights.
