There are no self-citations.</p> <p>2 Language evaluation: Classification: Grade A, Grade B, Grade B and Grade B. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: I found no "Author contribution" section.
