In general, it is a useful and well performed case report description. The questions raised by the reviewers should be answered; (3) Format: There is 1 figure; (4) References: A total of 8 references are cited, including 3 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
