A language editing certificate issued by AJE was provided. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. This manuscript is a re-submission of manuscript No. 61587 which suggested to transferred to WJMA. No financial support was obtained for the study. The topic has not previously been published in the WJMA. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) Authors should always cite references that are relevant to their study. Please check and remove any references that not relevant to this study; and (4) Please add table/figure to this review. 6 Recommendation: Conditional acceptance.
