The topic is within the scope of the WJCCM. (1) Classification: Two Grades B and Grade D; (2) Summary of the Peer-Review Report: The paper deals with an</p>	[Y]

interesting and up to date question and is of importance for the readership of the journal. The overall quality of the paper is good. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 4 figures. A total of 26 references are cited, including 19 references published in the last 3 years. There is 1 self-citation (Ref. 6). The topic of the self-citation is related to this study. 2 Language evaluation: Classification: Grade A and two Grades B. No language editing certificate was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCCM. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; and (4) Authors should always cite references that are relevant to their study. Please check and remove any references that not relevant to this study. 6 Recommendation: Conditional acceptance.
