2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a basic study of the differential analysis revealing APOC1 to be a diagnostic and prognostic marker for liver metastases of colorectal cancer. The topic is within the scope of the WJG. (1) Classification: Grade D, Grade A and Grade C; (2) Summary of the Peer-Review Report: The paper is very important and well designed. Early detection of colorectal metastases is very important for the prognosis of the disease. It was emphasized in the study that</p>	[Y]

metastases can be detected early. However, the questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 9 figures. (4) References: A total of 48 references are cited, including 5 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com.
