The topic is within the scope of the WJCCM. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors reported a well written manuscript with demonstration of a good understanding of GCR</p>	[Y]

and MR in sepsis patients and critical illness. However, the manuscript lacks any breakthrough information, and useful illustrations. The questions raised by the reviewer should be answered; and (3) Format: There are no tables and figures. A total of 70 references are cited, including 12 references published in the last 3 years. There are 4 self-citations, which are related to this study. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJCCM. 5 Issues raised: (1) The authors should add some figures or tables; and (2) Please obtain permission for the use of picture(s). If an author of a submission is re-using a figure or figures published elsewhere, or that is copyrighted, the author must provide documentation that the previous publisher or copyright holder has given permission for the figure to be re-published; and correctly indicating the reference source and copyrights.
