The topic is within the scope of the WJD. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors showed a review on the interferons (IFNs) role in diabetic retinopathy and propose detection of IFNγ as a potential biomarker of diabetic retinopathy. It is interesting and well presented. However, the questions raised by the reviewer should be answered; and (3)</p>	[Y]

Format: There are 3 tables. (4) References: A total of 131 references are cited, including 37 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations.
