The information summarized here significantly contribute to understand the current topics in the field and really helpful for the physician; (3) Format: There are 2 tables and 3 figures; (4) References: A total of 62 references are cited, including 28 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
