Science Editor: 1 Scientific quality: The manuscript describes a Case Report of compound heterozygous mutations in the GPR56 gene in a twin with lissencephaly. The topic is within the scope of the WJCC. (1) Classification: Grade A; (2) Summary of the Peer-Review Report: The paper is well-written and very interesting case report, and requires very minor polishing for grammar. The questions raised by the reviewers should be answered; (3) Format: There are 2 figures and 1 table; (4) References: A total of 22 references are cited, including 4 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
