new assessment of the mechanisms involved in changes that occur after fecal microbiota transplant in mice that have DSS-induced colitis. The level of detail provided for the methods is very helpful for understanding the rigor of the study as well as the analysis goals of the authors. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 6 figures. A total of 43 references are cited, including 36 references published in the last 3 years. There is 1 self-citation (Ref. 6). The topic of the self-citation is related to this study. 2 Language evaluation: Classification: Three Grades B and Grade C. No language editing certificate was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Animal Care and Use Committee Approval Form, and the Institutional Review Board Approval Form. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Scientific Research Project of Jiangsu Provincial Health Commission, Huai'an Natural Science Research Project. The topic has not previously been published in the WJG. 5 Issues raised: (1) The language classification is Grade C.
