The topic is within the scope of the WJD. (1) Classification: Grade A and Grade B; (2) Summary of the Peer-Review Report: This is a comprehensive review of the available cardiovascular risk assessment investigation tools in diabetic patients. questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 1 figure. A total of 195 references are cited, including 39 references published in the last 3 years. There are 18 self-citations (Ref. 27, 28, 29, 30, 64, 67, 70, 72, 73, 74, 100, 101, 115, 117, 125, 137, 156, 180). The topics of some self-citations are not very related to this study. 2 Language evaluation: Classification: Two Grades A. A language editing certificate issued by a native English speaker was provided. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJD. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) If an author of a submission is re-using a figure or figures published elsewhere, or that is copyrighted, the author must provide documentation that the previous publisher or copyright holder has given permission for the figure to be re-published; and correctly indicating the reference source and copyrights.
