The topic is within the scope of the WJD. (1) Classification: Grade B, Grade B and Grade B; (2) Summary of the Peer-Review Report: The authors found a review article discussing the impact of nutrition to prevent gestation diabetes mellitus. and comprehensive. However, the authors include in the text a summary analysis sheet (table) which results from their objective observations; and (3) Format: There are no tables and figures. (4) References: A total of 75 references are cited, including 9 references published in the last 3 years; (5) Self-cited references: There are 17 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
