(1) Classification: Grade C; (2) Summary of the Peer-Review Report: The article reviewed the causes, prognosis and management of liver injury in COVID 19. The finding the mechanism of liver injury in COVID 19 is challenging and significant for better treatment. tables and figures. (4) References: A total of 51 references are cited, including 49 references published in the last 3 years; (5) Self-cited references: There are 11 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
