Liver Cancer Guidelines and congratulations to the authors for delving into this topic. The reviewer requests the authors to lay more emphasis on patient selection criteria in the discussion part. The questions raised by the reviewers should be answered; and (3) Format: There is 1 figure. A total of 88 references are cited, including 33 references published in the last 3 years. There are 3 self-citations, which are all related to this study. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author's name, with no spaces; (3) Please obtain permission for the use of picture(s). If an author of a submission is re-using a figure or figures published elsewhere, or that is copyrighted, the author must provide documentation that the previous publisher or copyright holder has given permission for

the figure to be re-published; and correctly indicating the reference source and copyrights. For example, "Figure 1 Histopathological examination by hematoxylin-eosin staining (200 ×).
