The topic is within the scope of the WJG. (1) Classification: Grade A, Grade B and Grade B; (2) Summary of the Peer-Review Report: The authors conducted a systematic review and meta-analysis to evaluate the role of short-term weight loss</p>	[Y]

interventions in potential living liver donors with hepatic steatosis with the aim of increasing liver donation rates and improving donor, graft, and recipient outcomes. A very interesting and valuable research which will add to the scientific field, but chronological arrangement of the six included studies is recommended to be changed in all figures and table and in the discussion. Table 1 better to be conducted before figures. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 4 figures. A total of 28 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade A and Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and PRISMA 2009 Checklist. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
