(1) Classification: Grade B; (2) Summary of the Peer-Review Report: This review demonstrates an update in the risk and handling of SARS-CoV-2 infection in IBD focusing on the RAGE axis activation and cross-talk with the renin-angiotensin system. accompanied by the appropriate figure which illustrates the proposed prone mechanism activated in IBD patients with COVID-19. In conclusion, this is a very interesting review which provides insight into the inflammatory response SARS-CoV-2 infection in IBD patients including the RAGE axis activation and cross-talk with the renin-angiotensin system. These findings could help in understanding the mechanism of adverse outcomes SARS-CoV-2 infection in IBD patients; and (3) Format: There is 1 figure. A total of 102 references are cited, including 43 references published in the last 3 years. There are 4 self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) Please obtain permission for the use of picture(s). If an author of a submission is re-using a figure or figures published elsewhere, or that is copyrighted, the author must provide documentation that the previous publisher or copyright holder has given permission for the
