The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report:</p>	[Y]

This manuscript evaluated the diagnostic accuracy of alpha-fetoprotein, the Lens culinaris agglutinin-reactive fraction of AFP, and protein induced by vitamin K absence or antagonist-II and their combination for hepatocellular carcinoma diagnosis. Overall, the work is good and helpful. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 3 figures. A total of 30 references are cited, including 10 references published in the last 3 years. There are 2 self-citations (Ref. 2, 21). The topic of Ref. 21 seems not related to this study. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJG. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise

Please add the “Article Highlights” section at the end of the main text; and (5) Authors should not cite their own unrelated published articles. Please check and remove any references not relevant to this study.</p> <p>6 Recommendation: Conditional acceptance.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Gastroenterology, and the manuscript is conditionally accepted.
