The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The scientific quality of the manuscript is good. be answered; and (3) Format: There are 6 figures. A total of 39 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China, the 13th Five-Year Plan for National Key R&D Program of China. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID numbers are missing in the reference list. Please provide the PubMed numbers to the reference list and list all authors of the references. Please revise throughout; (4) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; and (5) Authors should always cite references that are relevant to their study. Please check and remove any references that not relevant to
