But, "Pancreatic cancer" and "PDAC" terms have been used interchangeably, the manuscript should be revised to remove these</p>	[Y]

inconsistencies. The questions raised by the reviewers should be answered; (3) Format: There is 1 figure; (4) References: A total of 35 references are cited, including 14 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations (kindly remind): The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com.
