The topic is within the scope of the WJD. (1) Classification: Grade A and Grade B; (2) Summary of the Peer-Review Report: This is a very well written review article providing a summary of the most important</p>	[Y]

psychosocial factors that influence the etiology and management of T1D in children and adolescents, with an emphasis on stressful life events and stress regulation inside the family dynamic. The questions raised by the reviewers should be answered; (3) Format: There are no tables and no figures; (4) References: A total of 49 references are cited, including 9 references published in the last 3 years; (5) Self-cited references: There are 3 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
